

ORDER OF THE MINISTER
OF NORTHERN DEVELOPMENT AND MINES
In the Matter of
SUBSECTION 26(3) AND SUBSECTION 26(6) OF THE
MINING ACT, R.S.O. 1990

AND IN THE MATTER OF:

The suspension of Prospector's Licence Number 1001711 issued in the name of Sam Kravchik;

AND IN THE MATTER OF:

The Prohibition of the acquisition of unpatented mining claims or interests therein through transfer or obtaining an Extension of Time or application for Lease;

AND WHEREAS:

A hearing held on June 2, 2005 in the matter of Prospector's Licence Number 1001711 pursuant to Subsection 26(3) and Subsection 26(6) of the *Mining Act*, R.S.O. 1990;

AND WHEREAS

Mr. Kravchik, haven been given notice of the hearing, chose to submit his arguments in writing rather than attend the hearing to contest the suspension of his licence or the prohibition of certain activities in respect of his interest in unpatented mining claims;

AND WHEREAS

The Provincial Mining Recorder subsequently recommended Mr. Sam Kravchik's licence be suspended;

AND WHEREAS

The Provincial Mining Recorder further recommended Mr. Sam Kravchik not acquire any unpatented mining claims or interest therein through transfer or obtain an Extension of Time in which to perform assessment work or apply for lease on any unpatented mining claims;

AND WHEREAS:

The authority to suspend or revoke a Prospector's licence pursuant to Subsection 26(3) of *the Mining Act* has been delegated to the Sr. Manager, Mining Lands Section, Mineral Development and Lands Branch, Mines and Minerals Division;

AND WHEREAS

The authority to order that the holder may not acquire an unpatented mining claim or interest therein through transfer or obtain an extension of time in which to perform work or to apply for lease on any unpatented mining claim recorded in the name of the holder pursuant to Subsection 26(6) of *the Mining Act* has been delegated to the Sr. Manager, Mining Lands Section, Mineral Development and Lands Branch, Mines and Minerals Division;

I HEREBY ORDER:

Pursuant to Subsection 26(3) of *the Mining Act*, R.S.O., 1990, that Prospector's Licence Number 1001711 issued in the name of Sam Kravchik be suspended for a period of five years effective January 10, 2006 up to and including January 10, 2011

I HEREBY FURTHER ORDER:

Pursuant to Subsection 26(6) Mr. Sam Kravchik may not acquire any unpatented mining claims or interest therein through transfer or obtain an Extension of Time in which to perform or assign assessment work on any unpatented mining claim listed in "*Schedule A*" or apply for lease on any unpatented mining claim listed in "*Schedule A*" for a period of five years, commencing on January 10, 2006 up to and including January 10, 2011.
