SECTION 35, THE MINING ACT, R.S.O. 1990

ORDER NO. W-TB-172/11

The SURFACE RIGHTS and MINING RIGHTS of the area outlined in red on the attached sketch, situated in the Townships and Areas as listed in the attached Schedule A, in the Porcupine and Thunder Bay Mining Divisions, containing 151,774 hectares more or less, are hereby WITHDRAWN from prospecting, staking out, sale or lease.

This area is WITHDRAWN for the Ministry of Natural Resources for a Transload Facility and Transportation Corridor.

Saving, excepting and reserving hereto and herefrom, all other lands patented, sold, leased or otherwise alienated by the Crown at the date of this Order.

Any alienated lands lying within the limits of this withdrawn area that revert to the Crown subsequent to the date of this Order will automatically be considered to be withdrawn as part of this Order.

This order comes into effect on January 17, 2012 at 12:01:01 a.m.

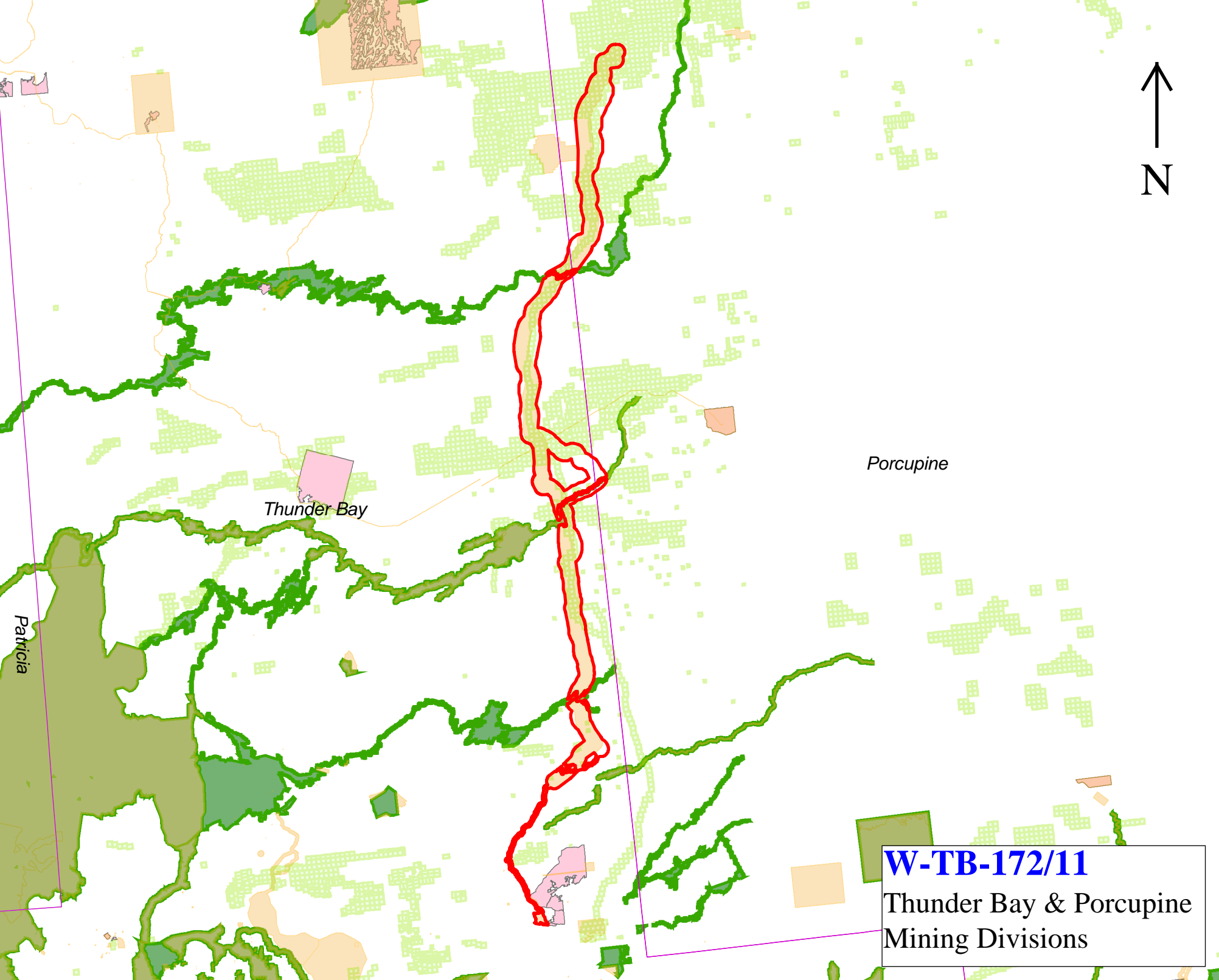
